

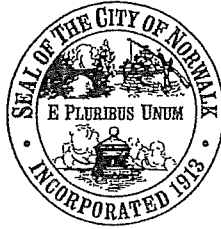

Re: Unlawful Enclosure of Public Utility Box

Dear Attorney Faye:

I write in response to a wooden enclosure your client caused to be placed over and around the Norwalk Parking Authority's (the "NPA") traffic control utility box within the perpetual easement / right of way area in favor the Norwalk Parking Authority between 69 and 71 Wall Street. See Attached. I was made aware of Mr. Milligan's self-help conduct yesterday afternoon. Upon consulting with the NPA's Director of Parking, Transportation and Mobility, the Department of Public Works and the Mayor's Office, the Law Department has determined that the enclosure presents an immediate health and safety hazard. Further, please be advised that this matter is contemporaneously being referred to Eversource as the electrical provider to the subject utility box.

By this letter, the City of Norwalk hereby demands that Mr. Milligan remove the enclosure immediately. In the event that the enclosure is not removed by 1:00 p.m. today, the City will mobilize a construction crew to remove it. Please further be advised that the City is contemplating referring this matter to the Norwalk Police Department as a criminal complaint for, among other things, potential violation of the anti-tampering statutes concerning public property. The City reserves all rights in law and equity, including, without limitation, seeking restitution in the event that further City resources are expended addressing this issue,
