On September 7, 2021, I was dispatched to Norwalk Redevelopment, 3 Belden Avenue, on a report of a disturbance. Dispatch advised that the Complainant, Norwalk Redevelopment, reported that approximately 90 minutes ago, Jason Milligan [REDACTED], came out from next door and started screaming at the Complainant's staff.

Upon my arrival, I made contact with Brian Bidolli, Executive Director of Norwalk Redevelopment. Mr. Bidolli advised that Mr. Milligan's office building is next to Norwalk Redevelopment, and that the parties have had several interactions in the past. Today, Mr. Bidolli stated that Norwalk Redevelopment had a meeting within their building with several city officials. When the meeting ended, the parties exited the building and were in the parking lot of 3 Belden Avenue when Mr. Milligan entered Norwalk Redevelopment's parking lot and was yelling at the individuals in the parking lot and it made them feel uncomfortable. He further stated that Mr. Milligan blocked in Steve Kloche's vehicle and lunged at him a couple times. Mr. Bidolli stated he did not witness the aforementioned behavior.

Mr. Bidolli stated that he then went into the parking lot and Mr. Milligan was screaming. Mr. Bidolli further stated that his staff is becoming concerned. Mr. Bidolli also stated that Mr. Milligan did not threaten him in the parking lot today. Mr. Bidolli stated that he wanted to document the incident today.

Mr. Kleppin is the Director of Planning and Zoning for the City of Norwalk. He called to document an incident which occurred earlier today following a meeting at the Norwalk Redevelopment Office at 3 Belden Avenue. He stated that following the meeting, at about 1430 hours, he was engaged with a resident who was also a party at the meeting, a Jason Milligan. He states that the argument became heated and he decided to leave the area. He states that as he entered his car and began to close the door, Mr. Milligan forced his shoulder between the car door as the door was being closed. Mr. Milligan then accused Mr. Kleppin of intentionally trying to injure him.

There was no further issue, but Mr. Kleppin wished to file a report to document the incident.
